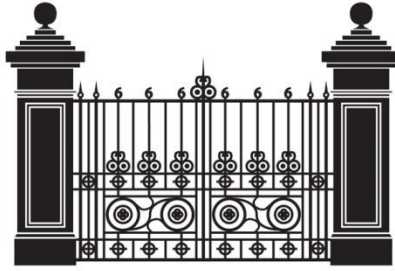

REGULATIONS AND CONDITIONS COVERING TRADE STANDS

1. Goods may be exhibited and sold on payment of the following fee:- The **MINIMUM** charge is £120 . The minimum depth is 6m. No booking “on the day” allowed.
2. When ordering frontage, take into consideration the overall size of your tent/vehicle/caravan, etc and order sufficient space to manoeuvre without encroaching on other stall holders space. Tickets, passes, authorisations, etc will be posted approximately one week before the Show. Additional tickets may be purchased in advance.
3. **Canwell Show starts at 8am and concludes at 6pm weather permitting.** Exhibitors may set up their displays the day before the Show and stands must be complete by 10 a.m. on Showday. Exhibitors must not commence dismantling any part of their exhibit before 6 p.m.
4. The Society’s Officers have the power to expel from the Showground any exhibitor or their representative who shall cause annoyance. No “Charity”, cheap-jack stalls, hawkers or similar persons are permitted to exhibit; the selling of goods by auction or annoying behavior is strictly forbidden.
5. No turf to be removed or holes dug in ground or branches cut all our trees are listed. No leaflet distribution is allowed. Sites to be left in a tidy manner; plastic bags are available on request.
6. Exhibitors are responsible for the safe custody of their property, the Society, its Officers and staff disclaim any responsibility and all liability in respect of any loss (damage, theft, fire, accident etc). It is agreed that the Society is indemnified as Principal and that insurance is carried.
7. Sites may not be transferred and no Exhibitor shall sublet or exchange or part with possession of the site allocated. Specific sites (with numbers) will be allocated and alternative sites will not be found.

8. Applications are received subject to the rights of the Society to refuse an application on any grounds it considers necessary and without entering into any correspondence.

9. All exhibitors and their representatives entering the Showground will be subject to the Rules and Regulations of the Society, and the jurisdiction of the Society's Officers.

10. All vehicles and/or property belonging to exhibitors **MUST BE REMOVED** from the Showground within 48 hours of the Show date. Failure to do so will result in any property being removed by the Society or its Officers and any incurred storage charges must be paid by the Exhibitor to the Society before that property is released to them. The Society accepts no liability for any loss or damage caused during removal.

11. All exhibitors are reminded that they must be aware of the potential risk their stand poses to the general public and take all appropriate precautions. Exhibitors must also comply with current Health & Safety regulations and completion of a risk assessment is required.

ALL EXHIBITORS ARE REQUIRED TO SUPPLY A SUITABLE FIRE EXTINGUISHER.

A COPY OF YOUR PUBLIC LIABILITY CERTIFICATE MUST BE SENT WITH THE APPLICATION FORM.

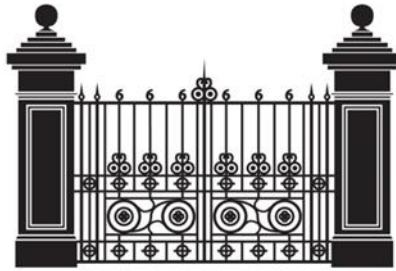
