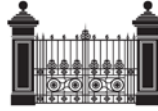

TERMS & CONDITIONS

1. Items may be exhibited and sold in the Food Marquee on payment of the following :-
Stands 3m long x 3m wide - £85.00 - A 240 volt electricity supply is provided for a £10 surcharge. Exhibitors should provide their own adapters and extension cables. The completed application form with the total fee should be forwarded to Mrs Z Morris,
2. **Exhibitors who wish to erect tall backboards to their stands must state this on their application form**, so that they can be allocated a stand which does not obscure other stands.
3. The Food Marquee will be open for the reception of exhibits etc. from 7.00 a.m. onwards and stands must be completed by 10.00 a.m. All vehicles must be removed from the Show area and avenues by 9.00 a.m. and taken to the Car Park. All Car Parks are accessible during the Show. NO PARKING will be allowed in the Show area or avenues during the Show and in the interests of safety, this Rules will be strictly enforced.
4. Exhibitors are solely responsible for the safe custody of their property, and the Society and its Officers and Staff disclaim any responsibility and all liability in respect of any loss (including damage, theft, fire, accident etc.). The Society strongly recommends that all Trade Exhibitors arrange adequate insurance to cover any loss.
5. **Exhibits must not commence dismantling any part of their trade stand exhibit before 6.00 p.m. without the permission of a Society Officer.**
6. Exhibitors will not be allowed to remove turf or dig up ground in any part of the Show area without the permission of a Society Officer. All holes must be filled in after use and turf replaced in a satisfactory manner. All rubbish must be placed in receptacles provided for the purpose.
7. Sites may not be transferred and no Exhibitor shall sublet or exchange or part with the possession of the site allocated to him without the written authority of the Secretary.
8. The Society and/or its appointed Officers have power to expel from the Showground any Exhibitors or their representatives who shall call attention to their goods in a manner which may cause annoyance. Vendors of cheap-jack articles, hawkers, commercial photographers and similar persons are not permitted to exhibit, and the selling of goods by auction, shouting or annoying behavior is strictly forbidden.
9. All displays, exhibits, and particularly moving machinery and electrical equipment must comply with the appropriate Health and Safety Regulations and any other regulations in force at the time.
10. Two admission tickets and one car pass will be issued to Exhibitors and these together with directions and instruction will be mailed approximately one week before the Show. Additional tickets may be purchased in advance.
11. Exhibitors who have not booked in advance will not be allowed to exhibit.
12. All applications are received subject to the rights of the Society to refuse an application on whatsoever grounds it considers necessary and without entering into correspondence.
13. All Exhibitors and their representatives entering the Showground will be subject to the Rules and Regulations of the Society and the Society's Officers.

ALL EXHIBITORS ARE REQUIRED TO SUPPLY A SUITABLE FIRE EXTINGUISHER.
A COPY OF YOUR PUBLIC LIABILITY CERTIFICATE MUST BE SENT WITH THE APPLICATION FORM.
